



Office Order No. 74 of 2019

In terms of Rule 4 of the Central Board of Direct Taxes (Regulation of Transaction of Business) Rules 1964, work in the Central Board of Direct Taxes is allocated/reallocated in respect of all matters and cases or classes of cases relating to the Benami Transactions (Prohibition) Act, 1988 and/or the Prohibition of Benami Property Transactions Act, 1988, as under :-

- A) All matters of Policy and Legislation relating to the Benami Transactions (Prohibition) Act, 1988 and/or the Prohibition of Benami Property Transactions Act, 1988 shall be considered by Member (Legislation), CBDT.
 - B) All matters and cases or classes of cases relating to the Audit & Public Accounts Committee, Court Cases before High Courts and Supreme Court and appointment of counsels in respect of the Benami Transactions (Prohibition) Act, 1988 and/or the Prohibition of Benami Property Transactions Act, 1988, shall be considered by Member (A&J), CBDT.
 - C) All matters and cases or classes of cases relating to the Benami Transactions (Prohibition) Act, 1988 and/or the Prohibition of Benami Property Transactions Act, 1988, other than those mentioned in clause (A) and clause (B) above, shall be considered by Member (Investigation), CBDT.
2. This issues with the approval of the Competent Authority and takes effect from the date of issuance of this order.


